Background:

In 2017, after being housed in North Bay City Hall, the DNSSAB Housing Programs department, including DNSSAB Housing Access (centralized waiting list) moved to office space at 133 Main Street West, North Bay (known as The Walkway building). There the department shared accommodations with the Nipissing District Housing Corporation (NDHC).

Housing providers may not have even noticed much difference as the DNSSAB was still accepting mail for the Housing Programs department at our City Hall address.

Recently, The Walkway building was sold and the DNSSAB Housing Programs department (along with DNSSAB Housing Access) has moved back to North Bay City Hall. NDHC administration (now working as DNSSAB Housing Operations department) has also moved their office to North Bay City Hall.

The move back to City Hall has resulted in a slight change to our mailing address as described below.
