Residential Tenancies Act, 2006

Background:

The Ministry of Municipal Affairs and Housing released Ontario's rent increase guideline for 2016. The 2016 guideline amount will be 2.0%. This is an increase from the 1.6% rent increase guideline amount in 2015.

The annual guideline is the maximum amount that most landlords can increase a tenant's rent without making an application to the Landlord and Tenant Board. The 2016 guideline was calculated under the Residential Tenancies Act, 2006 and is based upon the Ontario Consumer Price Index. Annual rent control guidelines are designed to recognize increases in building operating costs, so that housing providers can properly maintain properties and protect tenant health and safety, while at the same time ensuring that tenants can still pay their rent.

The 2016 guideline applies to a rent increase that takes effect between January 1, 2016 and December 31, 2016.

Action: Effective January 1, 2016 to December 31, 2016, increases to market rent must not exceed 2.0 % as per the 2016 Rent Control Guideline.
