## Background:

The annual rent increase guideline is the maximum amount that most landlords can increase a tenant's rent without making an application to the Landlord and Tenant Board. The 2020 guideline was calculated under the Residential Tenancies Act, 2006 and is based on the Ontario Consumer Price Index. Annual rent guidelines are designed to recognize changes in building operating costs, so that housing provers can properly maintain properties and protect tenant health and safety, while at the same time ensuring that tenants can still pay their rent.

The Ministry of Housing released Ontario's rent increase guideline for 2020. The 2020 guideline amount will be 2.2%. This is an increase from the 1.8% guideline amount for 2019.

#### Action:

The 2020 guideline applies to a rent increase that will take place between January 1, 2020 and December 31, 2020.

Effective January 1, 2020 to December 31, 2020, increases to market rent <u>must not exceed</u> <u>2.2%</u> as per the 2020 Rent Increase Guideline.
