JOB SUMMARY

Under the direction of the Supervisor of Maintenance Services, this position performs plumbing and HVAC duties of the entire housing portfolio.

This includes performing day-to-day preventative maintenance duties to ensure the preservation of the housing stock. Primary functions involve: plumbing and HVAC installations, repair, troubleshooting, and problem solving within the portfolio, in accordance with established standards, policies, procedures and in keeping with the Building Code, TSSA, Occupational Health and Safety, Fire Code and Residential Tenancies Act.

JOB DUTIES AND RESPONSIBILITIES

- Ensures the preservation of assets by performing a high standard of plumbing and HVAC duties, responsible for identifying and reporting potential of risk to protect the safety of our residents and our assets.
- Conducts and delivers the preventive maintenance program with an emphasis on mitigating risks throughout the entire housing portfolio and commercial buildings and keeps maintenance records.
- Seeks approval from the Supervisor for tasks not outlined in the job description.
- Requests a Work Order from the Maintenance Clerks prior to commencing any work or task.
- Completes Work Orders assigned and inputs tech notes upon completion.
- Perform this position in accordance with the scope of practice for the trade of plumber in the Building Opportunities in the Skilled Trades Act, 2021 (BOSTA).
- Read blueprints, drawings and specifications to determine layout of plumbing system, water supply network, waste and drainage systems, and HVAC systems.
- Install, repair and maintain domestic, commercial or industrial plumbing fixtures and systems.
- Install, repair, replace, and maintain gas heating systems, ventilation, boilers, hot water tanks, heat pumps, and air conditioning systems in residential and commercial buildings in accordance with industry standards and regulations.

- Locate and mark positions for pipe connections, passage holes and fixtures in walls and floors.
- Cut opening in walls and floors to accommodate pipe and pipe fittings.
- Measure, cut, bend and thread pipes using hand and power tools or machines.
- Join pipes using couplings, clamps, screws, bolts, cement or soldering, brazing and welding equipment.
- Test pipes and connections for leaks using air and water pressure gauges.
- Diagnose and troubleshoot issues with Hydronics and HVAC equipment and related systems and repair or replace faulty or defective equipment and components.
- General maintenance such as but not limited to drain cleaning, sump pump systems, grease interceptors, equipment cleaning, and equipment inspections.
- Perform move-out plumbing and HVAC work, renovations, and new construction.
- Replace, repair, and upgrade components with efficiency, cost savings, and longevity in mind.
- Clean-up worksite after work is performed.
- Maintains daily journal of work performed.
- Maintains inventory of supplies and submit orders to the office to replenish stock.
- Performs maintenance tasks in the event of emergencies as requested by the Supervisor.
- Performs other maintenance services related tasks such as and not limited to various inspections as required within housing operations.
- Reports safety hazards, incidents, and deficiencies to the Supervisor of Maintenance Services.
- Ensures equipment is in safe operating condition and stored safely and securely after each use.
- When assigned a vehicle, completes vehicle inspection reports on daily basis.
- When assigned a vehicle, reports any problems with the company vehicle(s) and transport for servicing.
- Keeps office, tools and supplies in a clean, organized, safe and secure manner.
- Trains, provides direction and supervises students or apprentices when assigned.
